Old Business:

- 1. Meeting called to order and opened in prayer by Susan Asberry
- 2. July minutes approval deferred
- 3. Prayer Charts for Walks 101 and 102 missing. Heather Cornette to look around FUMC for them.
- 4. Agape Room Door: Lock changed. FUMC has key. Gary Johnson to make copies for Board members who need a key. Code changed to prayer chapel door. Wooden crosses that were in the Prayer Chapel at the start of Walk 100 still missing. Hopefully these changes to security will prevent future loss.
- 5. Sale of EDGE: We are currently storing all beds and mattresses in this building. Rental of a storage shed would be approximately \$75.00 a month. Check with new owner to see if current storage situation can be continued.

New Business:

1. Agape report:

- a. Heather Cornette checked with the Upperroom and there is not an official "Agape" manual to be purchased. We were advised to use the 3 day schedule and add what we need Community Specific. So it is OK to copy our current Agape Manuals because they are Community specific.
- b. Recommended that the Agape manuals be turned into the Manual Coordinator to be placed in the Manual Totes. Recommended to make an inside and outside conference room tote due to the weight of the totes.
- c. The Upperroom is going to take back the 200 wooden crosses that were discovered during the cleaning of the Agape Room.
- d. Approval given to the Treasurer to add a "Debit Card" onto recurrent purchasing accounts. Treasurer will be the only approved user of this Card.
- e. Community has responded well to the request for Books. Thank You! Board Rep/Book Table to be careful when selecting books to be placed on Table during the Walk that they are Biblically sound and represent the UpperRoom bylaws and policies.

- f. Recommendation made that the Community be made aware of what is purchased for decorations etc. Offer Reunion Groups the opportunity to supply these materials. Recommend a 1 year/5 walk commitment from each Reunion Group interested. Rhonda to get with Jammie to send out a blast to the Community.
